## **ENTRY RULES**

### **ORGANIZER**

Falco Nero Photo Club

Patronat: FIAP 2020 / 227

Recognition: PSA 2020-174

### **CONDITIONS OF ENTRY**

The exhibition is open to anyone; however, an entry may be rejected when the sponsoring organization or its agent, in its reasonable discretion, believes the entry does not conform to the exhibition rules and conditions. An entrant's images will not be presented to the judges consecutively. An entrant's four images will be distributed throughout four rounds of judging in that section. Distribution of images shall be in the same round order as submitted by the entrant.

Entries must originate as photographs (image-captures of objects via light sensitivity) made by the entrant on photographic emulsion or acquired digitally. By virtue of submitting an entry, the entrant certifies the work as his own (aliases are not permitted). The entrant permits the sponsors to reproduce all or part of the entered material free of charge for publication and/or display in media related to the exhibition. This may include low resolution posting on a website. Note: Entrants who indicate that their images may not be reproduced or used "will not be eligible for awards" or inclusion in audio-visuals of the exhibition "and could be subject to disqualification" by the exhibition sponsors.

The exhibition assumes no liability of any misuse of copyright. Images may be altered, either electronically or otherwise, by the maker. All parts of the image must have been photographed by the author who is holding the copyright of all works submitted. All final work must be on photographic film, or on electronic file, or on photographic or electronic print material, mounting excepted. No title or identification of the maker shall be visible anywhere on the face of an image, print mat or mount entered in a PSA Recognized exhibition.

Each image must have a unique title. Once an image has been accepted in a PSA Recognized exhibition, that same image, or a like "in camera" or a "reproduction" duplicate of that image:

- i. May not be entered or re-entered in any section of the same Division Star Ratings class in that exhibition regardless of media, format, or title.
- ii. May not be re-titled for entry in any other PSA Recognized exhibition, including translation into another language.

Words such as "Untitled" and "No Title" are not acceptable as part or all of an image's title, nor are camera capture filenames.

## **BREACH OF CONDITIONS OF ENTRY**

If at any time, it is determined in the reasonable discretion of the exhibition organizer or the judges before, during, or after the judging of an exhibition that an entrant has submitted entries where one or more images may fail to comply with these Conditions of Entry, including the stated definitions, the exhibition organizers reserve the right to delete the entry from the exhibition and void any or all acceptances or awards in connection with the exhibition. Fees may be forfeited or refunded in these circumstances. The entrant acknowledges that the decision of the exhibition organizers or the judges is final.

In order to ensure that images comply with the Conditions of Entry and definitions, the exhibition organizers may carry out reasonable measures to verify that:

- a) the images are the original work of the entrant and
- b) the images comply with the rules and definitions as set out in these Conditions of Entry.

These steps include, but are not limited to, questioning any entrant, requiring the submission of RAW files or other digital files representing the original capture of the submitted image(s), confronting the entrant with evidence that one or more submitted images fails to comply with the Conditions of Entry (also known as Entry Rules), and offering the entrant a reasonable opportunity to provide counter evidence to refute the exhibition organizer's evidence by a set deadline. Such entries that are not cleared or are still questionable after the entrant has presented evidence may be considered in breach of these Conditions of Entry, and declined. Such entries may be referred to PSA for further investigation of possible ethics violations.

PSA retains the right to investigate in any way all complaints/suspicious of breaches of entry conditions, impose sanctions if deemed necessary, void the acceptances of any image found to violate the PSA rules, include the entrant's name on the list of sanctions provided to Exhibitions, and share such investigations with FIAP. Entrants automatically agree to these terms by the act of entering the Exhibition and agree to cooperate with any investigation.

## **LICENCE AGREEMENT**

By submitting an entry, the entrant certifies that he is a sole owner of the rights to use sent images, including copyright, patent and/or other applicable rights. All models must be of Legal Age of consent or have guardian permissions issued.

By the sole act of submitting his/her images or files to a salon under FIAP Patronage, the entrant accepts without exception and with no objection that the submitted images can be investigated by FIAP to establish if these obey to FIAP regulations and definitions even if the entrant is not a member of FIAP; that FIAP will use any means at its disposal for this undertaking; that any refusal to cooperate with FIAP or any refusal to submit the original files as captured by the camera, or failure to provide sufficient evidence, will be sanctioned by FIAP and that in case of sanctions following the non compliance with FIAP regulations, the name of the entrant will be released in any form useful to inform the breaches of the rules. It is recommended to leave the EXIF data in the submitted files intact in order to ease eventual investigations.

## **SUBMISSION OF WORKS**

**All authors must fill out an Online Entry Form on the official website.**

**Upload digital file format of prints to the site application form is also required.**

Photos must be in **JPG** file format. Maximal file size of 2MB.

The horizontal image side size (**longest**) of the photo must be **1920 px**; (vertical **1080 px**).

Any participant can submit up to 4 photographs under each theme.

**All prints must be printed on A4 paper**, by All Standards (29,7 x 21 cm / 30 x 20 cm / 11 x 8,5 inches ). Prints must be UNMOUNTED, and sent FLAT, NOT as a roll. The type of shipment should be a letter, not a package.

**The back of each photo must have the following info:** first and last name, artist's address, title of photo, progressive number and total number of photos presented by the same artist (example: 1/4, 2/4, 3/4 and 4/4) in each section.

**The title on the backs of the prints must match the titles on the Entry Form.**

No title or identification of the maker shall be written anywhere on the face of an image.

Only pressure sensitive (self-adhesive) labels may be used on the backs of unmounted prints.

The entrant must sign the entry submittal form in the space provided to verify authorization for the exhibition to destroy the exhibitor's prints in lieu of returning them otherwise the full entry fee shall apply if the exhibition does have separate fees for return of prints and non-return of prints.

Packages should be clearly marked on the outside:

**"PHOTOGRAPHS FOR EXHIBITION NO COMMERCIAL VALUE".**

#### **Return postage**

If prints need to be returned, return postage in addition to the entry fees must be paid 20 EUR or 23 USD per package. Price for the returning of the collective package will be arranged separately.

#### **FILE NAMING**

File name should be as you would want it to appear in the catalogue (same as title name).

Each image must have a unique title with maximum 35 characters (incl. space).

Only English alphabet and numeric allowed (A-Z a-z 0-9).

#### **RESULTS AND CATALOG**

The results and PDF catalog of the exhibition will be also published at our Website.

#### **RESPONSIBILITY OF THE ORGANIZER**

Organizer will take all possible care when handling the mail.

However, we do not accept any responsibility for damage or loss during transit.

#### **COMPETITION DIVISIONS**

All acceptances will count for FIAP and PSA distinctions and for inclusion in PSA Star Rating and "Who's Who". All acceptance eligibility shall be in accordance with the PID Star Ratings or the Galaxy/Diamond Ratings requirements as appropriate.

- Acceptances in PID recognized Color Sections shall be credited towards PID color Star Ratings and Who's Who Color listings.

- *Acceptances in PID recognized Monochrome sections shall be credited towards PID Monochrome Star Ratings and Who's Who Monochrome listings.*

- ***Monochrome images may be entered in PID Color sections but if accepted will only be eligible towards PID Color Star Ratings..***

#### **JUDGING**

The judges will Award the Acceptances, Medals and Honorable Mentions of the entered images. The one who has achieved the highest number of total acceptances of all the sections of the salon added together will be proclaimed "best author". Judges would use SONY Bravia KDL-43WF665 (43", Full HD, 1080P, 1920x1080). The target rate of acceptances is 25%.

## DEFINITIONS

### FIAP Monochrome

A black and white work fitting from the very dark grey (black) to the very clear grey (white) is a monochrome work with the various shades of grey. A black and white work toned entirely in a single colour will remain a monochrome work able to stand in the black and white category; such a work can be reproduced in black and white in the catalogue of a salon under FIAP Patronage. On the other hand a black and white work modified by a partial toning or by the addition of one colour becomes a colour work (polychrome) to stand in the colour category; such a work requires colour reproduction in the catalogue of a salon under FIAP Patronage.

### PSA Monochrome

An image is considered to be Monochrome only if it gives the impression of having no color (i.e. contains only shades of gray which can include pure black and pure white) OR it gives the impression of being a greyscale image that has been toned in one color across the entire image. (For example by Sepia, red, gold, etc.) A greyscale or multi-colored image modified or giving the impression of having been modified by partial toning, multi-toning or by the inclusion of spot coloring does not meet the definition of monochrome and shall be classified as a Color Work.

### Important:

*All entries shall conform to the stricter of these definitions for acceptances to be validated by all the International Organizations granting recognition or patronage.*

**T**he sponsors of this International Exhibition of Photography have been awarded Recognition by PSA, the world's largest patron of international photographic exhibitions. PSA, although it has provided Recognition, is neither a sponsor nor directly involved in the operation of this exhibition.

**Valid acceptances received by PSA Members in recognized sections of this exhibition are eligible for PSA Star Ratings, listing in the world-wide PSA Who's Who of Photography and credited towards the PSA Distinctions of QPSA, PPSA, EPSA, MPSA, MPSA2, GMPSA, GMPSA/B, GMPSA/S, GMPSA/G, and GMPSA/P.**
